



RAINWATER HARVESTING REBATE PROGRAM

AMWC Rainwater Harvesting Rebate, 5005 El Camino Real, Atascadero, CA 93422

PURPOSE: To reduce the amount of landscape water used by AMWC customers by installing cisterns or storage tanks to capture rainfall and offset demand during dry periods.

REBATE: Upon installation of a qualified Rainwater Harvesting System customers will receive a rebate of \$0.25 per gallon up to \$250, with a minimum requirement of a 100 gallon tank or cistern.

EXPIRATION: This application expires 120 days from the date of pre-inspection or when funds run out, whichever is earlier.

BACKFLOW PREVENTION: Backflow prevention devices are required for properties with existing wells, properties with booster pumps, fire service connections, landscape irrigation meters, and wherever the potential exists for cross-contamination of the community's water supply, as determined by AMWC. The customer is responsible for installing the backflow prevention device. Backflow prevention devices are to be installed downstream of, and as near as practicable to, the meter.

Backflow prevention devices are to be approved by the San Luis Obispo County Health Department. A current list of approved devices is available from the Health Department. AMWC may provide the customer with a list of backflow devices that have been approved by the County. The list provided by AMWC may not be current and is provided as a convenience only. The customer has the sole responsibility to determine that the County Health Department has approved the backflow prevention device to be installed.

RAINWATER HARVESTING REBATE PROGRAM TERMS AND CONDITIONS

REBATES ARE SUBJECT TO THE FOLLOWING CONDITIONS:

- Applicant must have a current, active account with AMWC in good standing.
- The application must be **completely and accurately** filled out.
- All rebates are subject to both pre and post-inspections. Sites must be pre-approved by AMWC Conservation Staff before any work is started in order to be eligible for a rebate. The program is not retroactive.
- Only one rebate is paid per owner per property. If you are a tenant, written permission to receive the rebate must be obtained in writing from the property owner.
- Retain a copy of this application and the sales receipts for your records.
- Rebates less than or equal to \$100 will be applied to the Shareholder's water account.
- Shareholders are advised that "before" and "after" photos of the landscape may be used for AMWC marketing and outreach.
