



PRESSURE REDUCING VALVE PROGRAM

- MAIL TO:** Atascadero Mutual Water Company, 5005 El Camino Real, Atascadero, CA 93422
- PURPOSE:** To provide an incentive for shareholders whose residential properties have static pressure of 80 pounds per square inch (psi) or higher. Reducing high water pressure saves water and prevents damage to pipes, appliance and water fixtures.
- REBATE:** Upon installation and inspection of the pressure reducing valve (PRV) per AMWC standards, eligible shareholders will receive a \$100 rebate credit for materials and labor. PRV's must be from AMWC's approved list below. Rebates will be applied to the shareholder's water account.
- EXPIRATION:** This application and required receipts must be received within 30 days of the PRV installation date to qualify. The rebate automatically ends when funds budgeted for the program are exhausted.

Terms and Conditions:

- Applicant must have a current, active account with AMWC. The account must be in good standing.
- The application must be **completely and accurately** filled out.
- Demonstration of a properly functioning PRV must be shown at the post-inspection. AMWC will conduct the post-inspection upon receipt of a complete and qualified application.
- The **PRV must be installed in a Rainbird VB-STD valve box or equal and must be easily accessible for maintenance.** The PRV must be installed within three feet of the meter box on the shareholder's side of the meter per the attached AMWC specifications.
- Shareholders must consider carefully any recommendations about changing the water pressure in the home and on irrigation systems. AMWC is not responsible for any problems that might occur with reducing the water pressure. Future maintenance, repair, or replacement of the PRV is the shareholder's responsibility.
- Properties must not have an existing PRV installed at the meter.
- New construction is not eligible.
- Multifamily, Commercial and Irrigation accounts do not qualify.
- Retain a copy of this application and the sales receipts for your records. Rebates may be subject to State and local taxes; applicants should check with their tax advisor.
- Only one rebate is paid per owner per property. Tenants and property managers are not eligible to receive the rebate.
- The program is not retroactive.
